Follow Up Questions from Virtual information Session on June 6, 2023

1. I am interested in the impact from Collingwood's perspective of the National Housing Strategy and the carve out for disabled peoples.

We recognize that people with disabilities face unique challenges in accessing affordable and appropriate housing and note that households with activity limitations make up 11.3% of owners and 44% of renters in core housing need in Collingwood. Representatives from local non-profits serving people with disabilities are included in stakeholder engagement with NBLC to ensure that people with disabilities are included in the master plan exercise.

2. How does Collingwood plan to implement affordable housing in the community when there is the issue of servicing capacity?

While water capacity continues to be a challenge for our community, the Town is able to allocate capacity to support shovel-ready development projects, to an upper limit every year. The Town's Servicing Capacity Allocation Policy (SCAP) includes a points-based system with extra points allocated for proposals with an affordable housing component, and we will continue to prioritize development projects with an affordable housing component. Further, a component of capacity has been set aside for municipally driven or public-private partnership affordable housing proposals. All shovel ready proposals advanced to date have received servicing capacity allocation and the Town continues to work on short-term solutions and the plant expansion.


3. How many homeless people do we have in Collingwood? Do we know their individual circumstances? Are they employed or seeking employment?

While hamelessness is a growing concern in Collingwood, it is important to under

While homelessness is a growing concern in Collingwood, it is important to understand that the Affordable Housing Master Plan focuses on finding solutions for moderate-income earners within the 4th to 6th income deciles. There is a key distinction between homelessness, social housing and affordable housing, though they can be related. They are all serious challenges in our community and across North America and they are happening concurrently. However, when we group the challenges together, we oversimplify the issues, duplicate efforts with other levels of government or agencies, spreading resources thinly, and risk creating obstacles instead of solutions. While the Town is focused on affordable housing, we do work closely with the County of Simcoe which is the lead level of government responsible for addressing homelessness and social housing. The graphic below helps clarify the roles, showing who leads discussions and receives related funding at the municipal level. 5. Will there be an opportunity to be added to a waitlist within the master plan for a unit?

The Affordable Housing Master Plan serves a broader purpose of exploring different approaches to support affordable housing. While building affordable housing is one possibility, it is not the sole focus of the master plan. The plan aims to examine a range of strategies and options that can contribute to affordable housing solutions. Developing a waitlist would be premature at this stage, as ultimate decisions regarding the outcomes of the master plan will be made by Council after careful consideration of all the factors involved and there are currently no units being constructed by the Town.
